# Part I Types of Foreign Talents

# 1. Foreign Talents Accredited by the Chinese Government

Those accredited by the state's competent authorities and hold a certificate issued by corresponding authority.

# 2. Foreign Talents Accredited by Guangdong Province

Those accredited by competent human resources departments of Guangdong Province and hold a certificate issued by corresponding department. For example, holders of "Confirmation Letter forForeign High-level Talents in Guangdong Province".

Senior foreign specialists and professionals who are employed and guaranteed by an enterprise accredited by the competent science and technology innovation authority of Guangdong or by Administrative Office of Guangdong Pilot Free Trade Zone (GDPFTZ) and foreign talents employed by institutions of higher

learning and research institutes in Guangdong.

# 3. Foreign Talents Accredited by Guangzhou Municipality

Foreign talents who are the holders of Talent Green Card of Guangzhou, or who meet the standards of high-end foreign talents (Class A) in the Classification Standards for Foreigners Working in China and accredited by competent human resources departments of Guangzhou.

# 4. Other Foreign Talents with Outstanding Contributions

Foreign talents who have made significant contributions or played an active role in the economic and social development and the opening-up process of Guangdong.

Those who have invested more than \$2 million in China in total as a natural person (or invested a total of \$500,000 in industries of encouraged type as specified by Catalogue for the Guidance of Foreign Investment Industries issued by China). And foreign nationals, acting as a natural person or a controlling shareholder

# Part II Facilitation Measures

### 1. Visas and Residence Permits

- (1) Foreign talents recognized by the Chinese Government or Guangdong Province and holders of Talent Green Card of Guangzhou may apply for multiple entries R visa with a valid period of no more than 5 years and the duration of stay of no more than 180 days.
- (2) After the duration of their stay expire in China, foreign talents recognized by the Chinese Government or Guangdong Province and holders of Talent Green Card of Guangzhou may apply for multiple entries R visa with a valid period of no more than 5 years and the duration of stay of no more than 180 days.
- (3) Foreign talents recognized by the Chinese Government or Guangdong Provincemay apply for residence permit with a valid period of no more than 5 years that is noted "Talent".
- (4) Foreign talents that come to Guangzhou for exchanges, visits, inspections, etc. may apply for multiple entries F visa

with a valid period of no more than 5 years and the duration of stay of no more than 180 days.

- (5) Foreign talents can apply for foreign employee's residence permit with a non-Z visa, an employment authorization and a letter of guarantee.
- (6) Foreign talentsthat have been recognized by competent human resourcesdepartments of Guangdong Province and have obtained permanent residence or foreign employee's residence permit in China may apply for private affairs residence permit (noted "household management services") for their foreign housekeepers within a corresponding period with a personal guarantee and an employment contract.
- (7) Relatives of Foreign talents, including their spouse, children under 18, parentsand parents-in-law may apply for visa/stay permit/residencepermit of the same valid period as themselves.

# 2. Permanent Residence

(1) Foreign talents recommended by Competent authorities of the state, Guangdong provincial people's government, Guangzhou Municipal Government or Guangdong Pilot Free Trade

Zone (GDPFTZ) Office, Guanzhou Economic and technological development zone office, Nansha Economic and technological development zone office, Zengcheng Economic and technological development zone office can directly apply for permanent residence in China.

- (2) Foreign members of innovation teams and foreign personnel employed by enterprises headquartered in Guangzhou shall be scored according to the evaluation criteria of talent points. If they reach a certain points, may apply for permanent residence in China.
- (3) Foreign nationals of Chinese origin who have a PhD degree or above and work in Guangzhouwith a work residence permit can apply for permanent residence in China.
- (4) After recommended by their employers, foreigners who have worked in Guangzhou for 4 consecutive years with a cumulative period of not less than 6 months in terms of actual residence in China each year and who, at the time of application, have received an annual salary income of more than RMB400, 000 (before tax) and paid more than RMB70, 000 of personal income tax each year for 4 consecutive years before the date of application

may apply for permanent residence in China.

After recommended by their employers, foreigners who have worked in Guangzhou for 4 consecutive years with a cumulative period of not less than 6 months in terms of actual residence in China each year and who, at the time of application, have received an annual salary income of more than six times of the average of the urban employees in the region where they worked in the previous years (before tax) and paid more than 20% of personal income tax each year for 4 consecutive years before the date of application may apply for permanent residence in China.

(5) Foreign talents who have accreditation certificate from the competent human resources authority of Guangdong Province, if they have been employed for 3 consecutive years in Guangdong Province with an employment-based residence permit marked "Talent" prior to submission of the application, may apply for permanent residence in China, upon recommendation of their current employer.

# 3. Green Channels

(1) Special service windows. Exit and Entry Administration

Bureau of Guangzhou Municipal Public Security Bureau has set up special service windows for foreign talents, who can get a service number at number-generating machine or information desk and apply for visa/stay permit/resident permit at special service windows.

- (2) Reservation free. After making an online appointment, foreign talentsmay apply for visa/residence permit without being subject to the limit of the appointed time.
- (3) Quick handling. Applications for visa/residence permit byforeign talents are generally completed within 3 working days, or at the same day of application under special circumstances.
- (4) Exclusive follow-up services. A specially-assigned person will provide follow-up services for foreign talents.
- (5) Family members of foreign talents may also enjoy green channel services.

3.1 Application for Visas/Residence Permits/Stay

# 3.1.1 Categories of Visas

Chinese visas are divided into diplomatic visas, courtesy visas, official visas and ordinary visas. Ordinary visas are further divided into the following categories and marked with corresponding Chinese phonetic alphabets:

- 1. The C visa, issued to crewmembersperforming duties on board international train, aircrafts, or vessel and the accompanying family members of vessel crewmembers, and vehicle drivers engaged in international transportation services.
- 2. The D visa, issued to persons who come to Chinafor permanent residence
- 3. The F visa, issued to people entering China for exchanges, visits, study tours, inspections or other relevant activities, etc.

- 4. The G visa, issued to people transiting through China.
- 5. J1 visa, issued to resident foreign correspondents of permanent offices of foreign news agencies in China; J2 visa, issued to foreign journalists for short-term news coverage in China.
- 6. L visa, issued to persons who come to China for travel; group L visa, issued to people engaged in group travels.
- 7. M visa, issued to people entering China for commercial trade activities.
- 8. Q1 visa, issued to foreign family members of Chinese citizens and foreigners with permanent residence status in China, who apply for residence in China for family reunion, and to foreigners who apply for residence in Chinafor fosterage or other purposes; The Q2 visa, issued to relatives of Chinese citizens living in China, and relatives of foreigners with permanent residence status in China, who apply for short-term residence in China for a short-term visit.
- 9. R visa, issued to foreign talents needed by China and specialists who are urgently needed by China.
- 10. S1 visa, issued to those who apply for long-term visit to China: the foreign spouse, parents, children under 18, parents-

in-law of foreigners that live in China for work, study, etc., and foreigners who need to stay in China for other personal matters; S2 visa, issued to those who apply for a short-term visit to China; foreign family members of foreigners that live in China for work, study or other purposes and to foreigners who need to stay in China for other personal matters.

11. X1 visa, issued to those applying for long-term study in China;

X2 visa, issued to those applying for short-term study in China.

12. Z visa, issued to people applying for work in China.

# 3.1.2 Categories of Residence Permits

- 1. Residence permit for work, issued to foreigners coming to Guangzhoufor work. It should be applied for within 30 days after entry into China with a Z visa.
- 2. Residence permit for study, issued to international students coming to Guangzhou for long-term study. It should be applied for within 30 days after entry into Chinawith an X1 visa.
- 3. Residence permit for journalist, issued to resident foreign journalists entering China. It should be applied for within 30 days

- 4. Residence permit for family reunion, issued to family members of Chinese nationals and foreigners with permanent residence status in China, who applyfor residence in Guangzhou for family reunion, as well as foreign children of foreign Chinese and overseas Chinese who are under age 18 and fostered in Guangzhou. It should be applied for within 30 days after entry into China with a Q1 visa.
- 5. Residence permit for personal matters, issued to the foreign spouse, parents, children under 18, parents-in-law of foreigners that live in Guangzhou due to work, study, etc., and to foreigners that need to stay in China for other personal matters like receiving medical aid or service. It should be applied for within 30 days after entry into China with a S1 visa.

# 3.1.3 Application Materials for Visa/ResidencePermit

1. First-Time Application for Residence Permit for Work
Foreigners coming to Guangzhoufor work with a Z visa shall

  - 2. Renewal of Residence Permit for Work
- (1) Original and photocopy of the applicant's valid passport or other international travel documents and visa;
- (2) A "Visa/Stay Permit/Residence Permit Application Form";
- (3) One digital photo and its "Receipt of China Visa Photograph for Foreigners in GuangdongProvince";
- (4) Valid "Registration Form of Temporary Accommodation for Visitors" in Guangzhou;
- (5) Copies (tobe checkedagainst the original) of "Foreign Expert Certificate", "Work Permit for Foreigners", "Work Permit for Foreigners Engaged in Offshore Oil Operations in the People's Republic of China" or an Letter of Approval for performance issuedby a competent Culture Department/Bureau;

  3. Visa Extension for Family Members (S2 Visa)
- Foreign family members of foreigners staying/residing in China for work, study, etc. (include: spouse, parents, parents-in-law, children, siblings, grandparents, grandchildren, and spouses of children), who come to China for short-term relative visitsand enter China with a S2 visa, if they need to stay after the expiration of visa, shall apply for a visa extension at least 7 days before visa expiration.

They should answer relevant inquiries and provide the following materials:

- (1) Original and photocopy of the applicant's valid passport or other international travel documents and visa:
- (2) A "Visa/Stay Permit/Residence Permit Application";
- (3) One digital photo and its "Receipt of China Visa Photograph for Foreigners in Guangdong Province";

(4) Valid "Registration Form of Temporary Accommodation for Visitors" in Guangzhou;

- (5) Proof of family relationship, copy of valid passport and residence permit of the person to be visited (to be checked against original), and letter from the above mentioned person;
- (6) Other certificates that the public security organ considers necessary.
- 4. Application for Residence Permits for family members of residential foreigners in Guangzhou

The spouse, parents, children under 18, parents-in-law of foreigners living in Guangzhou due to work, study, etc., who need to reside in China and enter with a S1 visa, shall apply for a residence permit for personal matters within 30 days of their entry.

They should answer relevant inquiries and provide the following materials:

- (1) The original and photocopy of the applicant's valid passport and visa;
- (2) A "Visa/Stay Permit/Residence Permit Application Form";

(3) One digital photo and its "Receipt of China Visa Photograph for Foreigners in GuangdongProvince";

- (4) Valid "Registration Form of Temporary Accommodation for Visitors" in Guangzhou;
- (5) "Health Certificate" issued by Entry-Exit Inspection and Quarantine Bureau of Guangdong Province (required when applying for residence permit for the first time);
- (6) When visiting a foreigner with residence permit in Guangzhou, photocopy of valid passport and residence permit of the above mentioned person (to be checked against original), an officialletter from the above mentioned person's working/studying unit, and certificates of relationship shall be provided;
- (7) Other certificates that the public security organ considers necessary.
  - 5. Application for Stay Permit

When foreigners who finished employment/work in Guangzhou need to continue to stay due to humanitarian reasons, they may apply for a stay permit at the exit and entry administration department of local public security organ.

# 3.1.4 Reissuance of Visa/Stay Permit/ResidencePermit

After entering China, if a foreigner's valid ordinary visa, stay permit or residence permit is lost, stolen or damaged, he/she may apply for a reissuance.

"Confirmation of Reporting the loss of Passport", or a diplomatic note issued by the embassy or consulate in China, or "Receipt of reporting to the police" by the local police station.

- (2) When a visa/stay permit/residence permit is damaged:
- i. Present the damaged passport;
- ii. Fill in "Incident/Case Report Form";
- iii. Submit a diplomatic note issued by the embassy of consulate in China, if any.
- (3) When a group visa is lost, stolen or damaged, the following documents shall be provided:

- i. "Receipt of reporting to the police" by the local police station:



- (4) When a residence permit is lost or stolen, the following documents shall be provided:
- i. "Confirmation of Reporting the loss of Passport", or a diplomatic note issued by the embassy or consulate in China, or "Receipt of reporting to the police" by the local police station;
- ii. An official letter from work unit/organization/educational institution if the applicant is a foreign employee/student in Guangzhou;
- iii. Original and photocopy of the visa used at the time of entry if the residence permit is lost or stolen outside China;
- iv. Another physical examination is required if the residence permit has been lost or stolen outside China more than 30 days ago.
  - (5) When a residence permit is damaged:
  - i. Present the damaged passport;
  - ii. Fill in "Incident/Case Report Form" and, if any, submit

- 3. When a change of registration items on the residence permitoccurs, the residence permit holder shall apply for a changeregistration at the issuing authority within 10 days from the

date of such change.

- 4. Applicants aged between 18 and 70 who apply for a residence permit for the first time shall submit "Health Certificate" issued by Entry-Exit Inspection and Quarantine Bureau of Guangdong Province, which is valid for 6 months from the issuing date.
- 5. Change of information on certificates issued by overseas institutions (such as marriage certificate, birth certificate, kinship certificate, adoption certificate, name, etc.) shall be authenticated by the Chinese embassy or consulate in the issuing country. Relevant certification materials in foreign language shall be translated into Chinese by a Chinese notary office.
- 6. If foreigners residing in China apply for extension of their stay, they shall apply at the exit and entry administration department of local public security organ at or above county level 30 days before the expiration of theirvalid residence permit.
- 7. When a foreigner apply for visa/stay permit/residence permit and meet acceptance requirements, the entry and exit administration department shall issue an "Application Receipt" and make the decision of issuanceor denial within the validity period of such

receipt. The application handling time is 7 working days (Time for investigation excluded). During the application, the applicant may legally stay in China with the "Application Receipt" while may legally stay in China with the "Application Receipt" while his passport or other international travel documents being kept by his passport or other international travel documents. - (2) Foreigners with outstanding contributions to China: foreigners who have made significant or outstanding contributions to China and who meet the special needs of China.
  - 2. Foreign Employees
- (1) Foreigners reaching certain assessment points: foreign members of innovation teams and foreign technical personnel employed by enterprises headquartered in Guangzhou, who have achieved 70 points or above according to the Guangdong Pilot Free Trade Zone (GDPFTZ) /Guangdong-Hong Kong-Macao Greater Bay Area points assessment standards.

# 3.3 Application for Foreigner's Accommodation Registration

After arriving in Guangzhou, foreigners shall go through formalities of temporary accommodation registration in accordance with Article 39 of the Exit and Entry Administration Law of the People's Republic of China.

For foreigners living in hotels or other hospitality agencies, the hospitality agency shall register their accommodation.

For foreigners who reside or stay indomiciles other than hotels, they or the persons who accommodate them shall, within 24 hours after foreigners' arrival, go through the registration formalities with the public security organ in the places of residence.

Temporary accommodation registration shall be updated in a timely manner when the validity of the accommodation registration expires or visa/stay permit/residence permit is changed.

For accommodation registration, the following materials should be submitted:

(1) One photocopy of the lodging foreigner's valid passport or other international travel documents (personal information page including photo page) and valid visa/stay permit/residence

### Part IV Related Instructions

1. Policies Enjoyed by Foreigners with Permanent Residence Status in China

"Foreign Permanent Residence ID Card" (hereinafter referred to as "the ID Card" for short) is a legal identity document for foreigners who have obtained permanent residence status in China, which can be used separately.

### Foreigners holding the ID Card can:

- (1) In principle, enjoy equal rights and shoulder equal obligations like Chinese citizens, except for political rights and those specific rights and obligations as stipulated by laws and regulations.
- (2) Reside in China with no time limitation, enter and exit China with a valid passport and "Foreign Permanent Resident ID Card" without going through other formalities like visa

application. Their spouse and immediate family members can apply for corresponding visa, residence permit or "Foreign Permanent Resident ID Card" according to relevant regulations.

- (3) Inward and outward articles for personal use shall go throughformalities in accordance with relevant provisions of China Customs on passengers with permanent residence.
- (4) Exempt from "Foreigner's Work Permit" when working in China; those who meet relevant requirements can enjoy priorities when apply for "Foreign Expert Certificate", "Returning/Repatriate Expert Certificate" and local Work and Residence Certificate for Talents.
- (5) Establish foreign-invested enterprises through technology shareholding or investment etc., and use renminbi lawfully obtained to make foreign direct investment within the territory of China.
- (6) When investing in projects in China and establishing foreign-invested enterprises, enjoy simplified authorization and expedited approval procedures by relevant departments like development and reform, commerce, industry and commerce, foreign exchange, etc. in accordance with provisions on foreign

- (7) Participate in qualification assessmentfor professional and technical positions, as well as qualification examination for professional and technical personnel according to regulations.
- (8) If the children of a foreigner with permanent residence status are in the compulsory education stage and meet relevant requirements, the education administrative department of their place of residence shall handle relevant issues like enrollment and transfer by the principle of nearest admission, without charging extra fees other than those prescribed by the Chinese government regulation.
- (9) The "Foreign Permanent Resident ID Card" can be used as a valid identity certificate for participating in social insurance. Those who work in China shall participate in various social insurances in accordance with relevant provisions of the Social Insurance Law of the People's Republic of China. Those who reside in China but not employed and meet the requirements of overall local regulation, can participate in the basic medical insurance and social pension insurance of urban residents with reference to local Chinese urban residents. When handlingissues

like transfer and termination of their social insurance, social insurance agencies shall simplify procedures and provide convenience to them in accordance with relevant regulations.

- (10) Deposit and use housing provident fundat the workplace in accordance with regulations such as Regulations on Management of Housing Provident Fund, and withdraw or transfer the housing provident fundaccordingto relevant regulations when leaving the area.
- (11) Purchase commercial real properties for personal use and reside in China in accordance with other relevant regulations, exempt from the requirement that foreign individuals purchasing commercial properties should work or study in China for at least one year, which is stipulated in Opinions on Regulating the Entry of Foreign Investment into the Real Property Market and the Administration Thereof.
- (12) In respect of paying income tax, fulfill corresponding tax obligations in accordance with relevant provisions of China's tax laws and regulations and tax treaties.
- (13) Use the "Foreign Permanent Resident ID Card" as an identity certificate in financial activities like banking, insurance,

securities, futures, etc., enjoy the equal rights, obligations and statistical attribution like Chinese citizens.

- (14) Exchange income obtained in China into foreign currency and remitted abroad with tax payment certificate issued by the taxation department after taxespayment according to the law. Use the "Foreign Permanent Resident ID Card" as an identity certificate in foreign exchange business in accordance with relevant regulations on foreign exchange.
- (15) Enjoy the equal treatment and price like Chinese citizens in domestic shopping, tickets purchase for parks and various cultural and sports venues, and other consumption activities like culture, entertainment, business and traveling in China.
- (16) Go through relevant boarding procedures with the "Foreign Permanent Resident ID Card" when taking domestic flights. Purchase train tickets with the ID Card while traveling train in China. Check in with the ID Card when lodge in hotels in China.
- whenapplying for a motor vehicle driving license and motor vehicle registration. In case of firstapplicationor replacement application for a "Motor Vehicle Driver's License of the People's Republic

of China" with an oversea driver's license, once meeting the requirements for license application or renewal and having passed relevant examinations, a "Motor Vehicle Driver's License of the People's Republic of China" shall be issued by the public security department with the "Foreign Permanent Resident ID Card", proof of accommodation registration issued by public security department and certificate of physical condition. In application for motor vehicle registration, the applicant may go through relevant formalities at public security department with the "Foreign Permanent Resident ID Card", proof of accommodation registration issued by public security department, and relevant certificate and vouchers of motor vehicle.

### 2. Disqualification of Permanent Residence

For a foreigner who has acquired the qualification for permanent residence in China, the Ministry of Public Security may cancel his/her permanent residence status in China and take back or

declare his/her Foreign Permanent Resident ID Card invalid under any of the following circumstances:

- (1) He/she may endanger China's national security or interests;
  - (2) He/she has been sentenced to deportation;
- (3) He/she acquired the qualification for permanent residence in China by illegal means, such as providing false information;
- (4) He/she stays in China for less than three months each year, or less than one year in total within five years without permission.

### 3. Application instructions for Work Permit

To work in Guangzhou legally, foreigners should obtain a work permit (except forcircumstances exempted by laws and regulations).

# 第二章 便利服务措施

# 一、签证证件便利服务措施



- 1. 外国人进行签证、停留、居留证件申请,需先登录广州金盾网(www.gzjd.gov.cn)业务申请专区选择"外国人证件办理"进行网上预约申请,或亲临出入境大厦境外人员网上申请区进行现场预约。为外国人签证、停留、居留证件申请出具证明函件的单位还需登录广州金盾网(www.gzjd.gov.cn)业务申请专区选择"涉外单位备案"进行网上备案,备案审核通过后的单位在进行外国人签证、停留、居留证件申请时无需提交注册登记证明。
- 2. 外国人在中国境内工作必须同时持有工作许可和工作类居留证件。
- 3. 外国人居留证件登记事项发生变更的,持证件人应当自登记事项 发生变更之日起10日内向居留证件签发机关申请变更。
- 4. 18至70周岁的申请人首次办理居留证件时应提交广东省出入境 检验检疫局出具的《健康证明》。《健康证明》自开具之日起6个月内有效。
- 5. 境外机构出具的婚姻证明、出生证明、亲属关系证明、收养证明、姓名等资料变更证明,应经中国驻该国使领馆认证。有关外文证明材料应当经国内公证机关翻译成中文。
- 6. 在中国境内居留的外国人申请延长居留期限的,应当在居留证件有效期限届满30天前向居留地县级以上公安机关出入境管理部门提出申请。

7. 外国人申请签证证件符合受理规定的,公安机关出入境管理部门应当出具受理回执,并在受理回执有效期内作出是否签发的决定。标证时限为7个工作日(有关事项需要公安机关调查核实的,调查时间不计入工作日)。申请人所持护照或者其他国际旅行证件因办理证件被收存期间,可以凭受理回执在中国境内合法停留。如需乘坐飞机、火车等前往境内其他城市的可申请在受理回执上加盖出入境管理专用章。申请人应当在受理回执注明的取证日期当天前往公安机关出入境管理部门领取护照。

# 二、永久居留办理

- (2) 加注"人才"类: 持工作类居留证件(加注"人才")工作满三年的外籍高层次人才。
- (3) 市场认定类:在广东已连续工作满4年、每年在中国境内实际居住累计不少于6个月,申请时及申请之日前连续4年工资性年收入(税前)40万元人民币以上,每年缴纳个人所得税7万元人民币以上的外国人。

在中国境内工作的外国人,连续工作4年、每年实际居住不少于6个月,工资性年收入不低于上一年度所在地区城镇在岗职工平均工资的六倍,年缴纳个人所得税不低于工资性年收入标准20%,可申请在华永久居留。其外籍配偶和未成年子女可随同申请。

- (4) 一般任职类:在符合条件的单位担任副总经理、副厂长等职务以上或者具有副教授、副研究员等副高级职称以上以及享受同等待遇满四年,四年内在中国居留累计不少于三年,且纳税记录良好的外国人。
- (5) 华人博士类: 具有博士研究生以上学历且持工作类居留许可在广州市工作的外籍华人。
- (6) 华人任职类:在广州市企业连续工作满4年、每年在中国境内 实际居住累计不少于6个月的外籍华人。
  - 3. 投资人员

- (1) 一般投资类:以自然人身份在中国投资合计200万美元或在 家颁布的《外商投资产业指导目录》鼓励类产业投资合计50万美元以上 的,连续3年投资情况稳定,且纳税记录良好的外国人。
- (2) 大湾区投资类:以自然人身份或者通过本人以自然人身份情 为控股股东的公司企业,在粤港澳大湾区9市内直接投资、连续3年投资 情况稳定、投资数额合计100万美元(国家颁布的《外商投资产业指导 录》鼓励类产业投资合计50万美元)以上且纳税记录良好的外国人。

#### 4. 随行家属

- (1) 配偶类:政府认定类、突出贡献类、一般任职类、一般投资 类、市场认定类人员的外籍配偶可随申请人同时申请在华永久居留。
- (2) 子女类: 政府认定类、突出贡献类、一般任职类、一般投资 类、市场认定类人员的未满18周岁的外籍未婚子女可随申请人同时申请 在华永久居留。 5. 团聚

- (1) 夫妻团聚类: 配偶为广州市常住户籍的中国公民或者在中国获 得永久居留资格的外国人,婚姻关系存续满五年且申请之日前已在中国 连续居留满五年、每年在中国居留不少于九个月的外国人。
- (2) 亲子团聚类: 父母双方或一方为广州市常住户籍的中国公民或 者在中国获得永久居留资格的外国人,未满18周岁且未婚的外国人。

居留满五年、每年在中国居留不少于九个月,投靠境内直系亲属的,年满60周岁的外国人。

# 三、外国人住宿登记办理

外国人抵穗后,应按照《中华人民共和国出境入境管理法》第 三十九条规定办理临时住宿登记手续。

住在酒店、宾馆等旅业部门的, 由旅业部门为外国人办理住宿登 记。

在旅馆以外的其他住所居住或者住宿的,应当在入住后24小时内由 本人或者留宿人,向居住地的公安机关办理住宿登记。

住宿登记有效期满或签证证件发生变更的情况下, 应及时更新临时 住宿登记。

# 申报住宿登记时应提交以下资料:

- (一) 住宿人的护照或有效证件的身份资料页(有照片页)和有效 签证(签注)页复印件各一份;
- (二)属于租赁房屋的,应提交租赁合同和房产证明材料复印件各 一份;
  - (三) 申报临时住宿登记时,住宿人需提供一张大一寸照片;
  - (四) 在中国居民家中留宿的,需交验留宿人的户口簿或身份证;

(五) 在外国人家中住宿的,需交验留宿人的有效出入境证件;

(六) 在我市的机构内留宿的, 需交验单位证明。

### 第四章 相关政策及指引

## 一、外国人在华永久居留享有相关待遇

《外国人永久居留证》是获得在中国永久居留资格的外国人在中国境内居留的合法身份证件,可以单独使用。凡持有中国《外国人永久居留证》的外籍人员可享有以下待遇:

- (一)除政治权利和法律法规规定不可享有的特定权利和义务外,原则上和中国公民享有相同权利,承担相同义务。
- (二)在中国居留期限不受限制,可以凭有效护照和《外国人永久居留证》出入中国国境,无需另外办理签证等手续;其配偶及直系亲属,可按有关规定申请办理相应签证、居留证件或《外国人永久居留证》。
  - (三) 进出境自用物品按照海关对定居旅客的有关规定办理手续。
- (四)在中国就业,免办《外国人就业证》;符合条件的,可优 先办理《外国专家证》《回国(来华)专家证》以及各地人才工作居住 证。
- (五)可以技术入股或者投资等方式创办外商投资企业,可以合法 获得的人民币在中国境内进行外商直接投资
  - (六) 在中国投资项目、设立外商投资企业的,发展改革、商务、

工商、外汇等部门按照外资管理有关规定简化核准及审批程序,提高效率。

- (七)可按规定参加专业技术职务任职资格评审和专业技术人员资格考试。
- (八)随迁子女义务教育阶段入学,符合条件的,可享受相关政策,由其居住地教育行政部门按照就近入学的原则办理入、转学手续,不收取国家规定以外的费用。

- (九)可以《外国人永久居留证》作为有效身份证件办理参加社会保险各项手续。在中国境内就业的,按照《中华人民共和国社会保险法》有关规定参加各项社会保险;在中国境内居住但未就业,且符合统筹地区规定的,可参照国内城镇居民参加城镇居民基本医疗保险和城镇居民社会养老保险,享受社会保险待遇。办理社会保险关系转移接续、终止等手续,社会保险经办机构按照有关规定简化流程、提供方便。
- (十)可按照《住房公积金管理条例》等规定,在工作地缴存和使用住房公积金,离开该地区时,可按规定办理住房公积金的提取或转移手续。
- (十一)可不受《关于规范房地产市场外资准入和管理的意见》中 关于境外个人在境内购买自用商品住房需在境内工作、学习超过一年的 限制,按照其他有关规定在境内购买自用、自住商品住房。
- (十二)在缴纳所得税方面,按照中国税收法律法规以及税收协定的有关规定,履行相应的纳税义务。

(十三)在国内办理银行、保险、证券和期货等金融方面业务,可以《外国人永久居留证》作为身份凭证,享有中国公民同等权利、义务和统计归属。

(十四)在国内取得的收入,依法纳税并持有税务部门出具的对外 支付税务证明后,可兑换外汇汇出境外。可以《外国人永久居留证》作 为身份凭证,按照相关外汇管理规定办理外汇业务。

(十五)在国内购物、购买公园及各类文体场馆门票、进行文化娱 乐商旅等消费活动与中国公民同等待遇、价格相同。

(十六)乘坐中国国内航班,可凭《外国人永久居留证》办理有关 登机手续;在国内乘坐火车,可凭《外国人永久居留证》购买火车票; 在国内旅馆住宿,可凭《外国人永久居留证》办理有关入住手续。

(十七)在申领机动车驾驶证和办理机动车登记方面,享受中国公民同等待遇。初次申领或持境外机动车驾驶证换领《中华人民共和国机动车驾驶证》,符合驾驶证申领或换领条件的,可凭《外国人永久居留证》、公安部门出具的住宿登记证明、身体条件证明,经考试合格后,由公安机关核发《中华人民共和国机动车驾驶证》。申请办理机动车登记,可以凭《外国人永久居留证》、公安部门出具的住宿登记证明及机动车相关证明、凭证,到公安部门办理机动车登记业务。

理。 (十八) 加入或恢复中国国籍,公安部门按照有关手续,加快办理。

### 二、在华永久居留资格的丧失

具有在中国永久居留资格的外国人有下列情形之一的,经中华人民 共和国公安部批准,可以取消其在中国永久居留资格,同时收缴其所持 外国人永久居留证件或者宣布作废:

- (一) 可能对国家安全和利益造成危害的;
- (二)被人民法院判处驱逐出境的;
- (三) 通过提供虚假材料等非法手段骗取在中国永久居留资格的;
- (四)未经批准每年在中国累计居留不满三个月或者五年内在中国 累计居留不满一年的。

### 三、工作许可证办理指引

外国人在广州合法工作,应取得外国人来华工作许可(法律法规规 定免办的情形除外)。申办指引如下:

#### (一) 申办流程

- 1. 首先网上提交申请材料: 登录国家外国专家局"外国人来华工作管理服务系统"(http://fwp.safea.gov.cn/)提交申请材料。首次办理前请先在该系统注册。
- 2. 后续至受理机构现场办理: 网上预审通过后,用人单位到相应受理机构现场,办理纸质材料受理(全流程网办业务除外)、领取证件等业务。
